I spoke to Suzanne Terry to express the desire to have the decking flush with the rear doors of the house for 3 main reasons: safety, aesthetics, proportions of the garden. Part of Suzanne's correspondence is quoted here: "If you wish now for a decked area in excess of 300mm in height, you would need to make a re-submitted planning application to the Council. The Council will then principally assess the impact of the increased decking height in terms of likely impact on neighbouring amenity, for example through overlooking and loss of privacy. Therefore, anything you can do to mitigate against these impacts would be beneficial to your application."

To have the decking flush with the rear doors to the property, the height would be 0.48m from the ground directly adjacent to the house. However the garden is on a downward slope towards the house, and if level the height would be significantly less than the permitted 0.3m.

Since this correspondence, we have replaced the dilapidated fences at the rear and left of the property, which now provide adequate privacy between our property/garden, and the neighbours.
