Details of the pre-application advice received

- Brook Close benefits from a mixture of single and two storey detached properties of varying ridge heights. An argument can be made that the increase in height would not be harmful to character of the surrounding area or the amenity of neighbouring properties.
- Side extension and its roof being of similar height to that of the main gabled roof form, may relate poorly to the design of the main dwelling and would look incongruous in the street scene owing to its scale, bulk, mass and roof form.
- The extensions would detract from the original character of the existing dwelling, its impact exacerbated by the gabled roof form of the side extension which would likely be judged as an uncharacteristic feature of a street which is generally characterised by hipped roof dwellings.
- The degree of inset between the extended dwelling and no. 7 means the projection of the extended dwelling beyond this neighbouring property would be within reasonable tolerances in terms of loss of light, outlook and privacy.
- Particular care needs to be taken on the impact of the proposal on outlook and light received by the flank windows of the neighbouring property.
