Details of the pre-application advice received

The rear/side extension would be built up to the eastern boundary. The side part of the extension would be set well back from the front boundary of the site. According to council guidance generally, houses can be extended from the rear wall of the original dwelling by up to 4m in depth for a semi-detached dwelling to ensure the extension is subordinate to the original dwelling. Any greater depth required should be within an angle of 45 degrees, taken from the 4m dimension on the property boundary, in order to ensure a reasonable level of amenity is afforded to neighbouring properties. It is noted that the attached neighbour has an existing infill extension that would mitigate some of the impact of the proposal and the height of the rear extension would be relatively low at under 3m, however this would need to be fully assessed in a planning application.

Rejected application P0455.23 had a 4.85m extension, the new application is for a 4m rear extension
