Key Discussion Points:

If planning permission was to be sought for the flank window, the officer considers that the development could receive officer support as it would be unlikely to be harmful to the street scene or amenity of neighbouring properties.

The applicant queried whether planning permission would be required for the flank window. The officer was of the opinion that planning consent was unlikely to be required for the development but advised the applicant to submit a Lawful Development Certificate (LDC) to the Council in order to receive formal clarification about this matter.

The officer indicated that in the eventuality that a LDC for the flank window was allocated, a decision on the application could be expedited.
