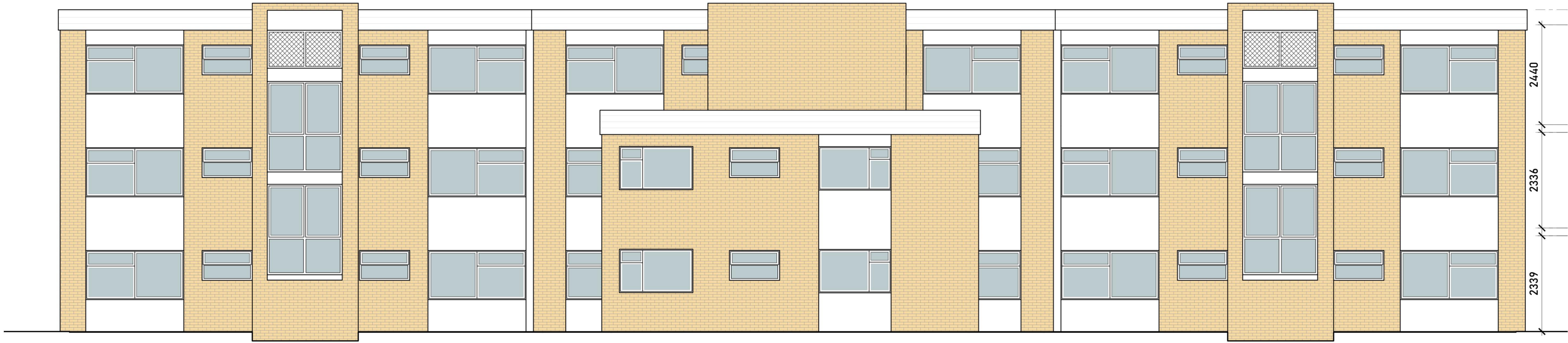
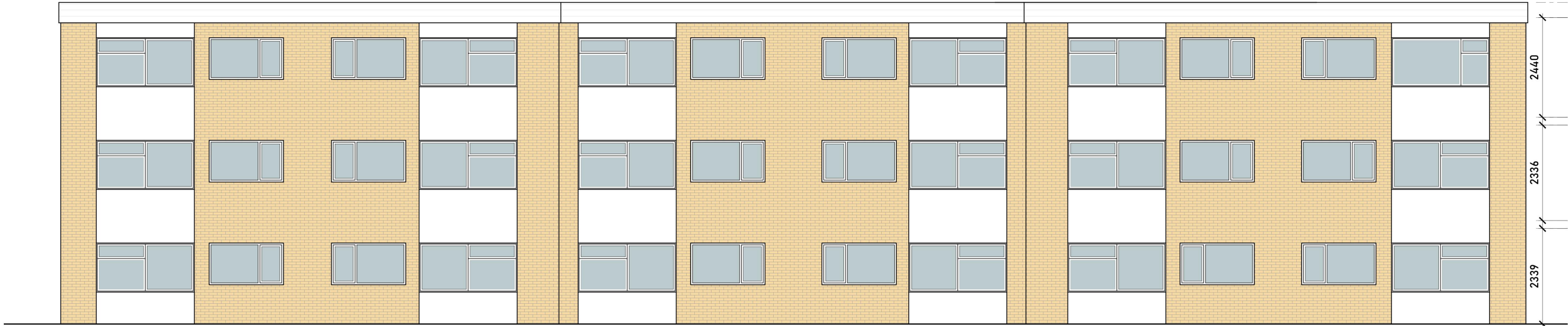




Existing Rear (North) Elevation

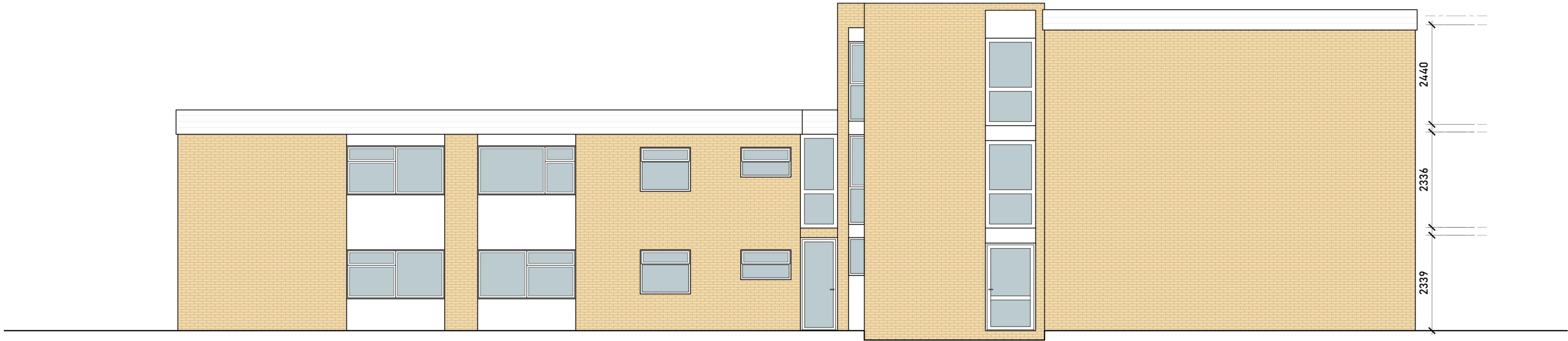

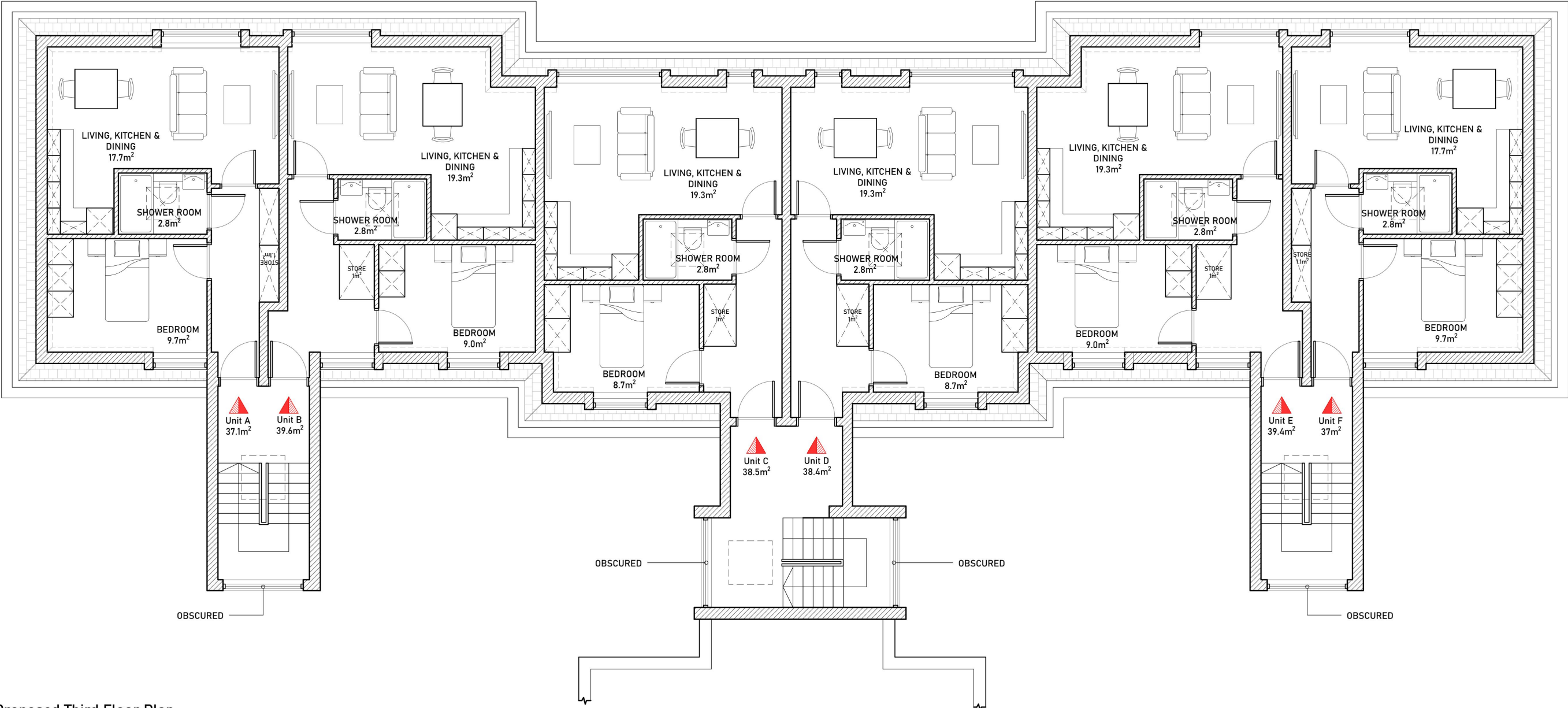

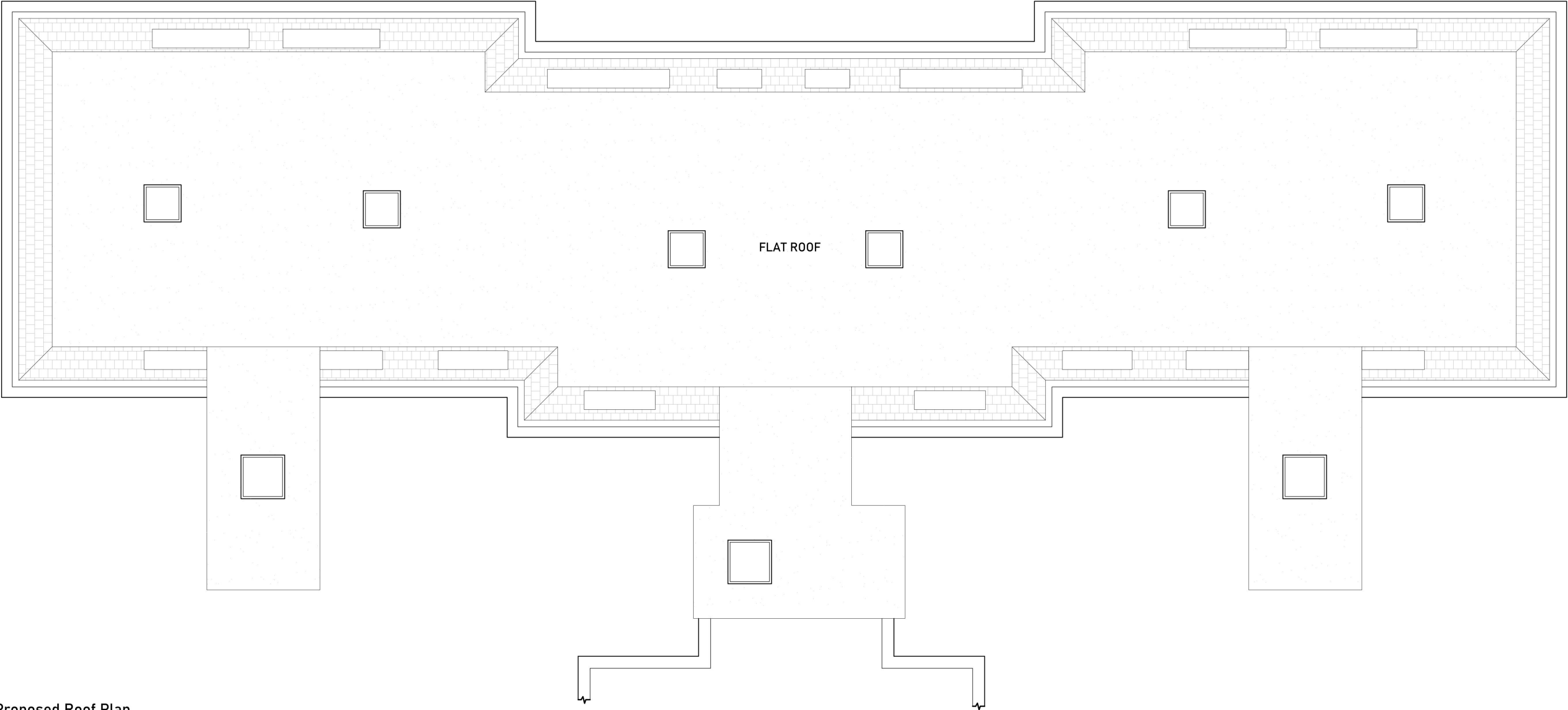

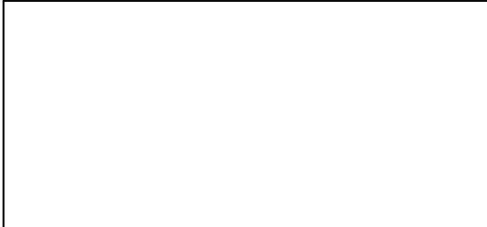
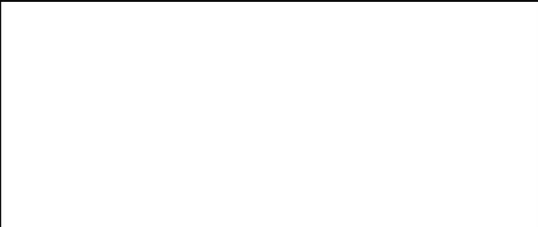
Proposed Side (East) Elevation

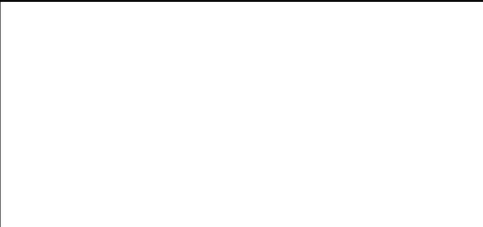
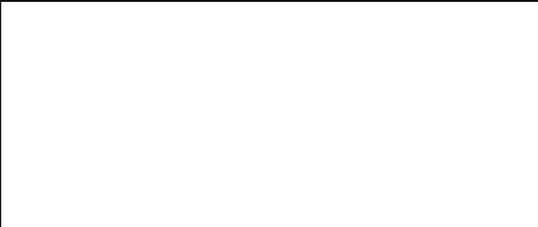
