Details of the pre-application advice received

Following discusses with Aidan Hughes (planning manager) we decided to withdraw the application for a Demolition of existing single storey rear extension and erection of part single, part two storey rear extension P1709.23. As part of the works to the loft and outbuilding the rear extension and existing outbuildings have been demolished.

Concerns were raised in regards to the depth of the first floor extension and the roof typology of the ground and first floor extension.

Further discusses have been had with Aidan Hughes to find a positive design solution. Please refer to design evolution.
