Details of the pre-application advice received

Discussed my original proposal for 3.1m deep and 5m wide extension. The case officer measured the depth of the extension from the neighbours (No. 8) rear wall which is not set out in the Havering policy document but is a view of the council. On that basis the case officer asked to apply a 45 degree angle which resulted in an infringement of my extension which is already just 3m. I have received advice from independent planners also. In this application I have provided extension amount of information to prove that my plans have no material impact on the neighbouring amenities. I have provided several evidence for direction of sun/day light. This time I am also including a signed consent letter from No. 8 (relevant neighbours) confirming my extension has no impact to their day light or privacy. It is because No. 8 sits on the south side to me and it is actually my property which is over shadowed by No. 8.
