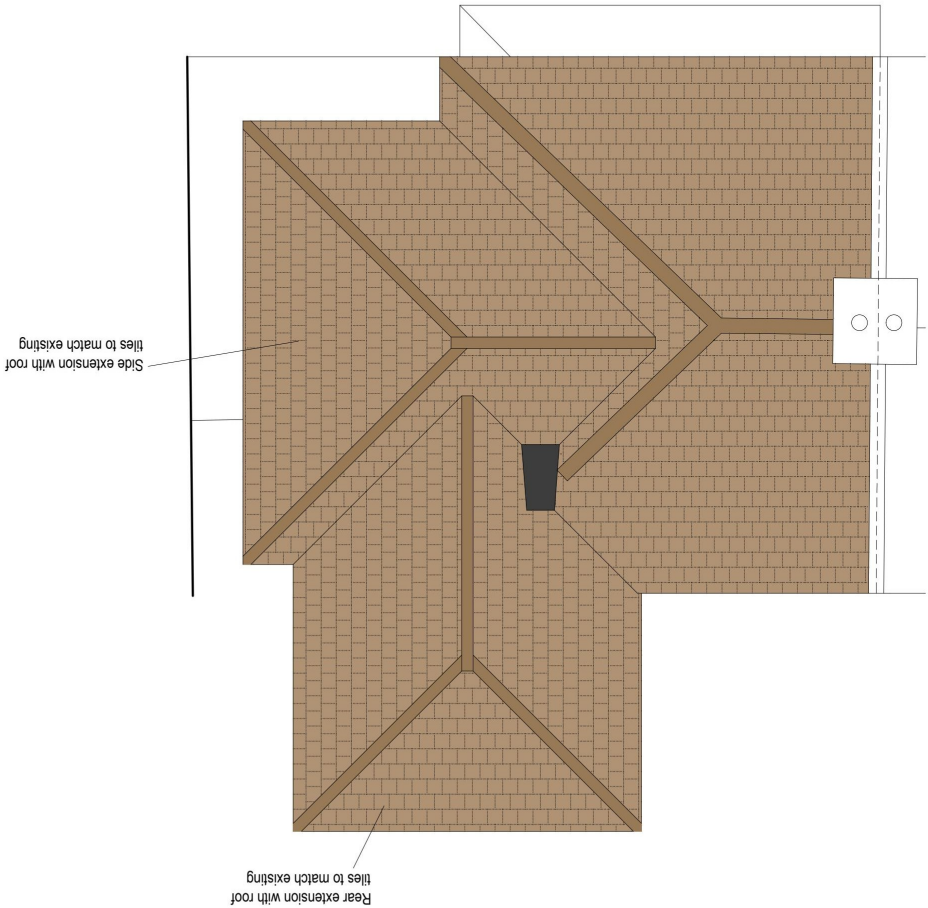


GROUND FLOOR PLAN

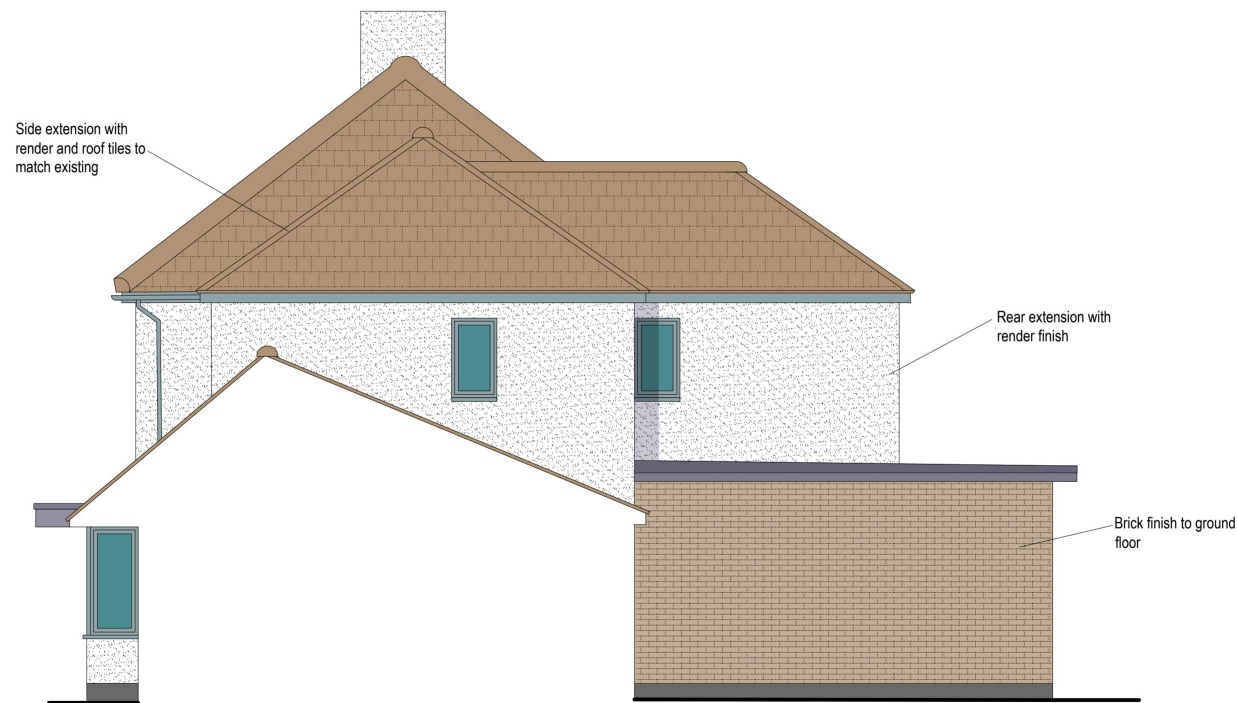

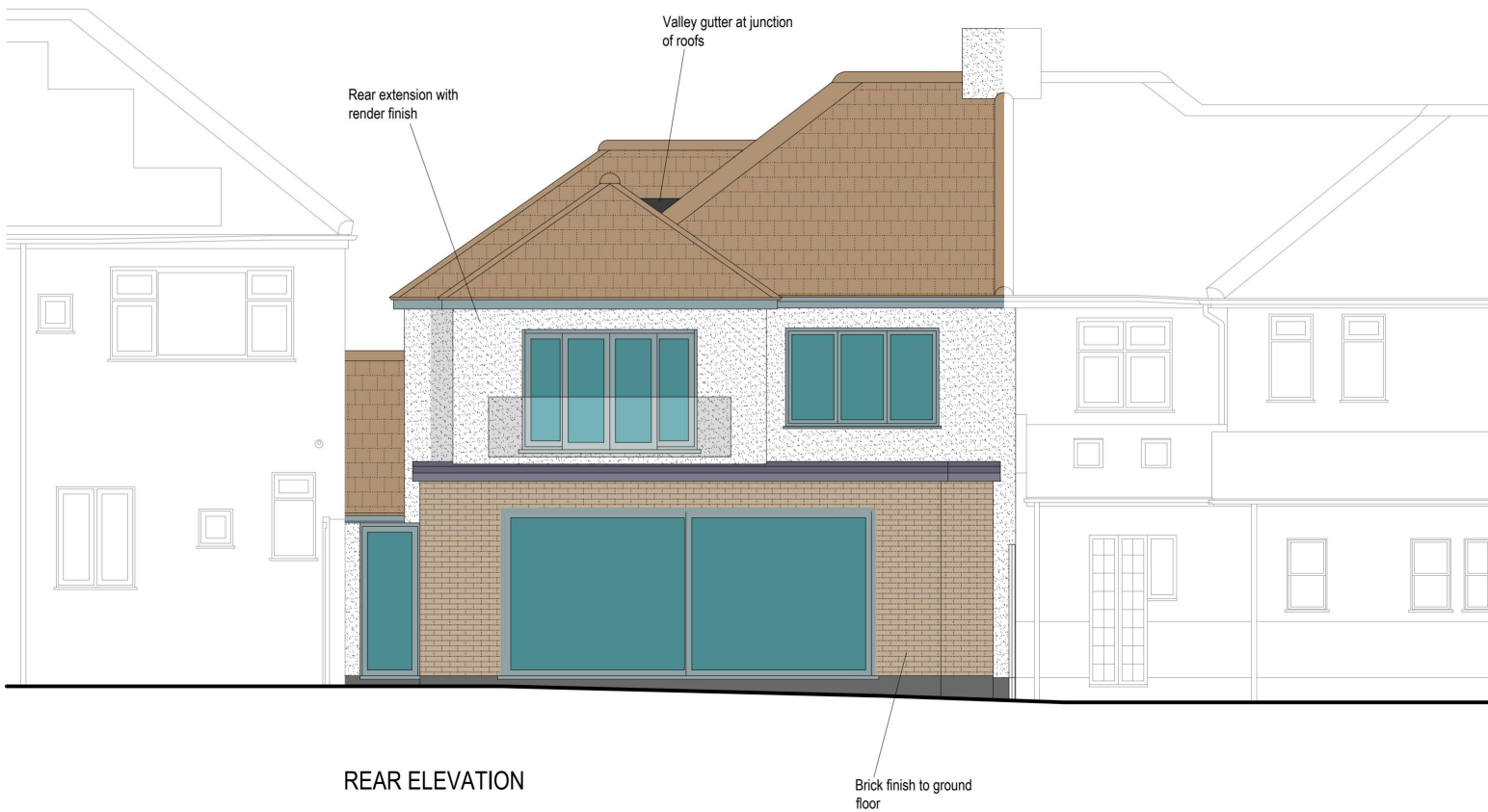

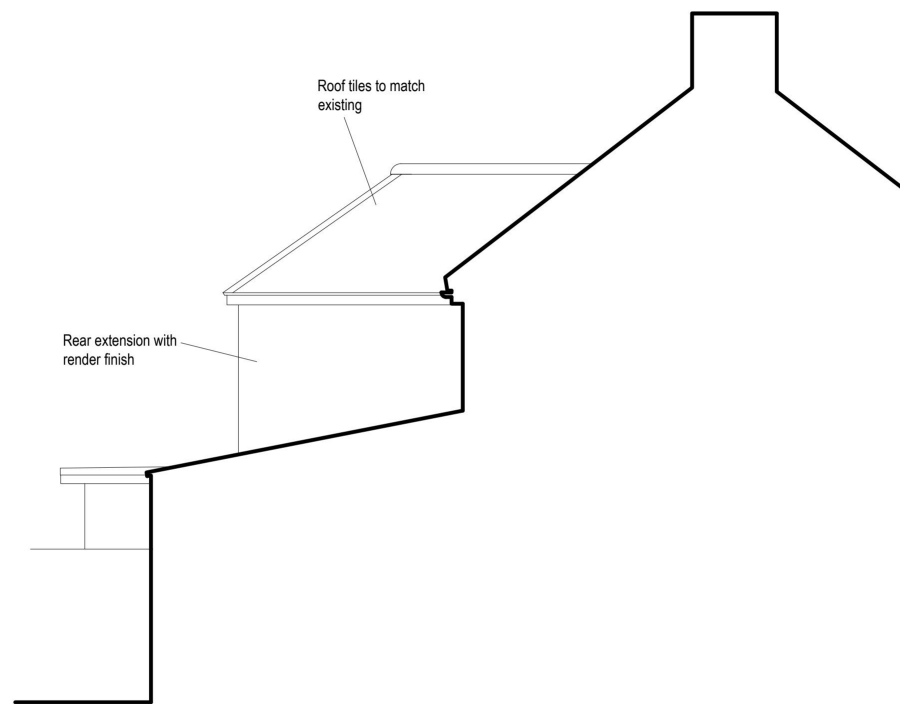
FRONT ELEVATION
