Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The external volume of the proposed loft conversion with rear dormer and hip to gable conversion is 40.38m³ which is less than the 50m³ allowance for semi-detached houses. The dormer is set back more than 20cm from the eaves. The height of the conversion does not exceed the highest part of the existing roof. Therefore the proposals are permitted under Class B of the 2013 GPDO.
