Biodiversity net gain does not apply as the development is subject to the de minimus exemption as the applicant impacts less than 25 sqm of non-zero distinctiveness habitat and less than 5 sqm of hedgerow and does not impact priority habitat. This is a minor extension of approximately 8 sqm on an existing hardstanding (paved) area. In addition to paving to the front, there is hardstanding for two cars to the rear and a tarmac access road to the side of the site. These existing sealed surfaces are typically assigned a zero score in the statutory biodiversity metric and are effectively exempted from the 10% net gain requirement. In short, there are no on-site habitats (priority or otherwise) to be lost or downgraded by the proposed extension.
