The proposed subdivision of an existing residential dwelling into two self-contained flats qualifies as a minor development and falls within the de minimis exemption under the Biodiversity Net Gain (BNG) regulations, as it does not exceed the relevant thresholds for BNG applicability. The development affects an area of less than 25 square metres of natural habitat and less than 5 metres of linear habitat, such as hedgerows. Importantly, the site does not include any priority habitats, and the affected land comprises entirely of sealed surfaces, including existing built structures and hardstanding (e.g. paving or tarmac), which are deemed to have zero baseline biodiversity value under the statutory biodiversity metric. As there is no loss of habitat or ecological value, and no opportunity for measurable biodiversity enhancement within the scope of this proposal, the scheme is effectively excluded from the mandatory BNG requirements. This position is consistent with guidance issued by DEFRA and Natural England, which confirm that BNG does not apply to small-scale developments where ecological impact is negligible and no priority habitat is affected.
