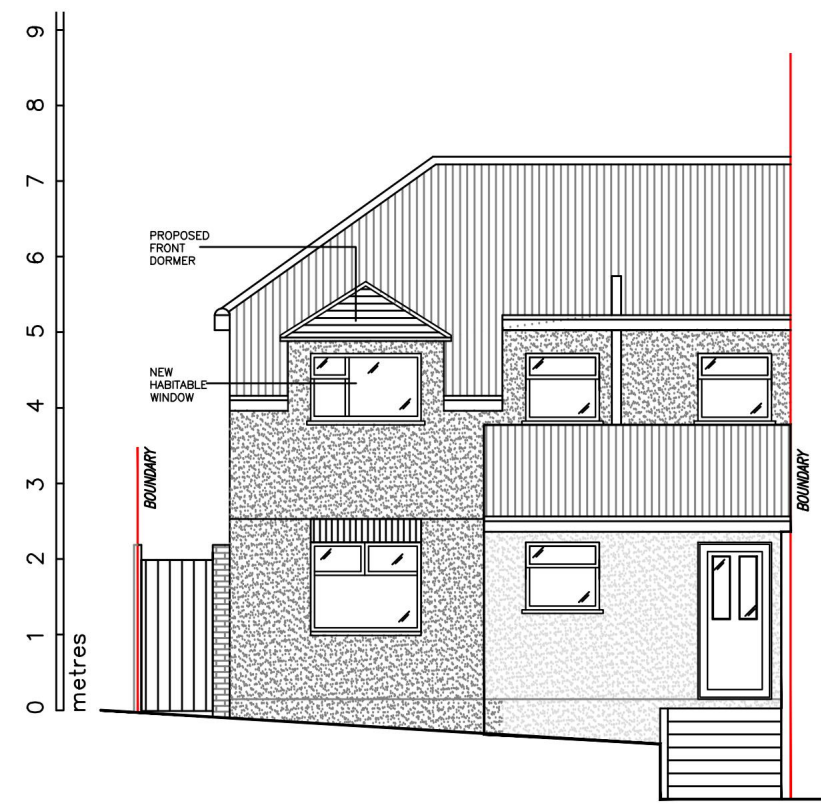
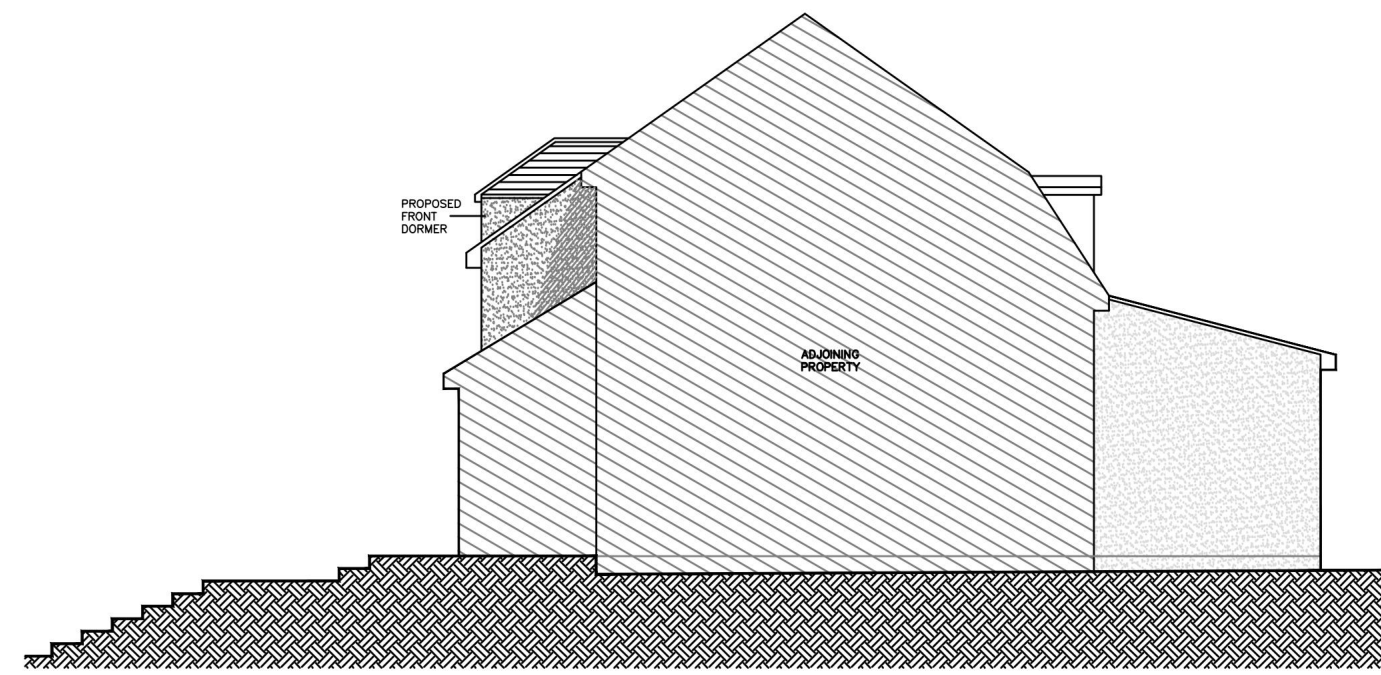
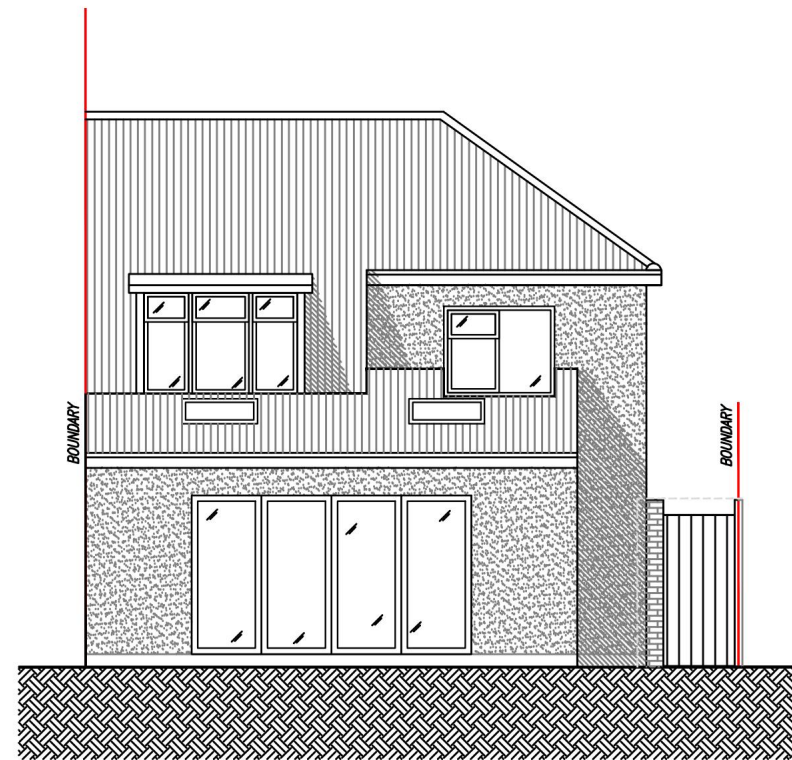




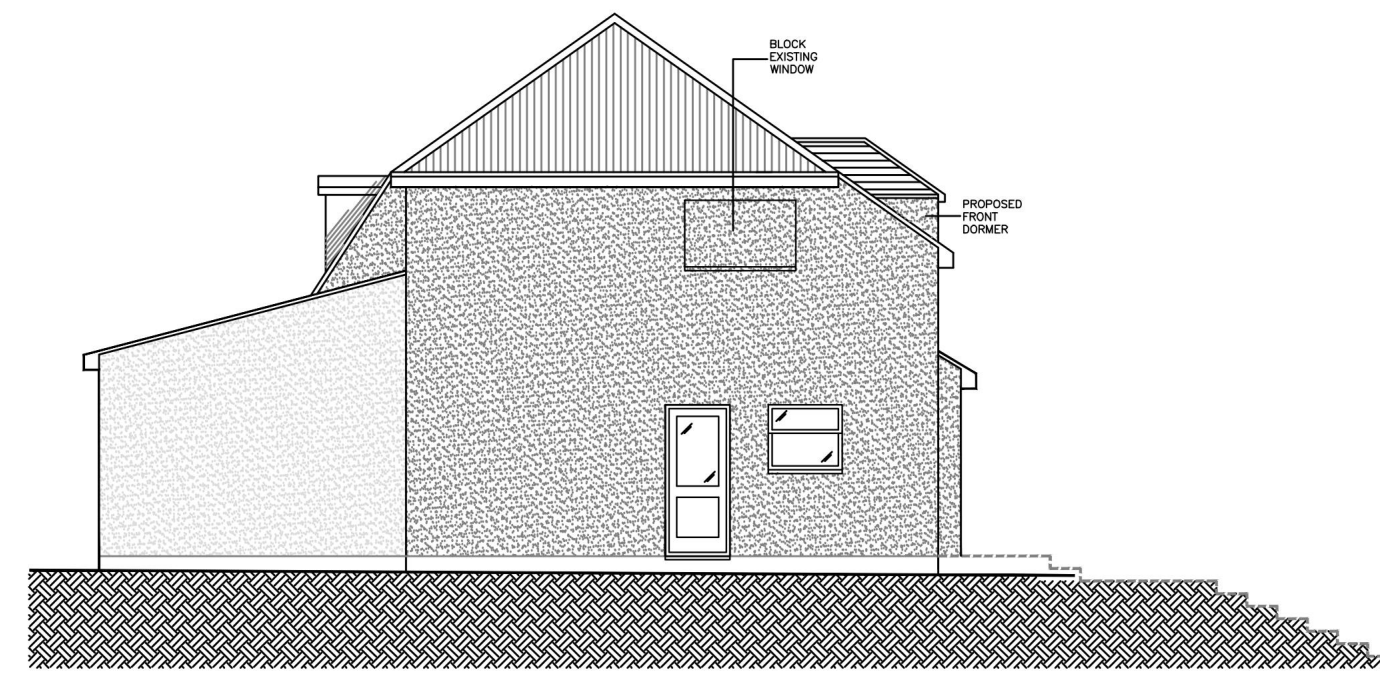
PROPOSED FRONT ELEVATION

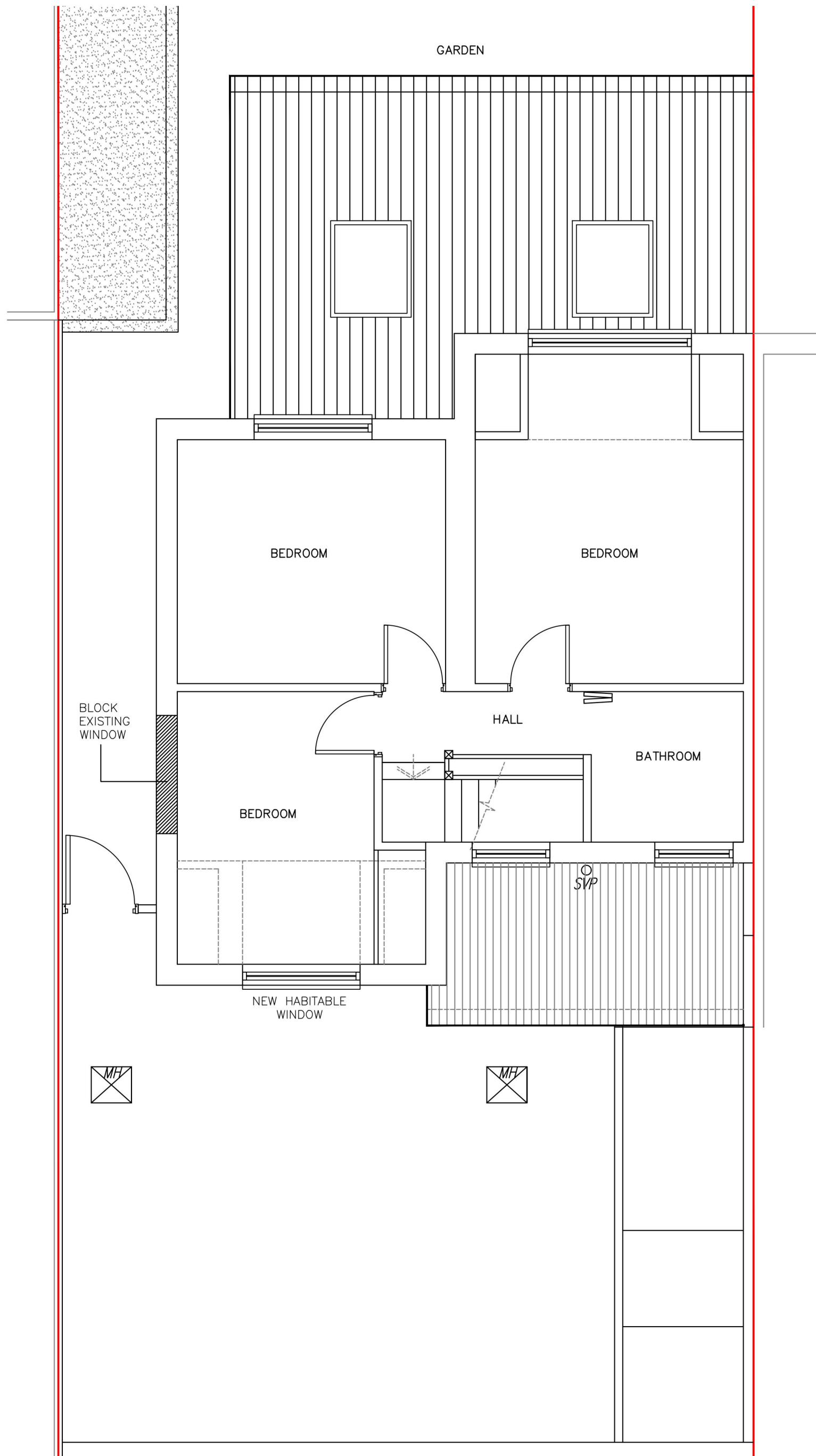
PROPOSED SIDE ELEVATION

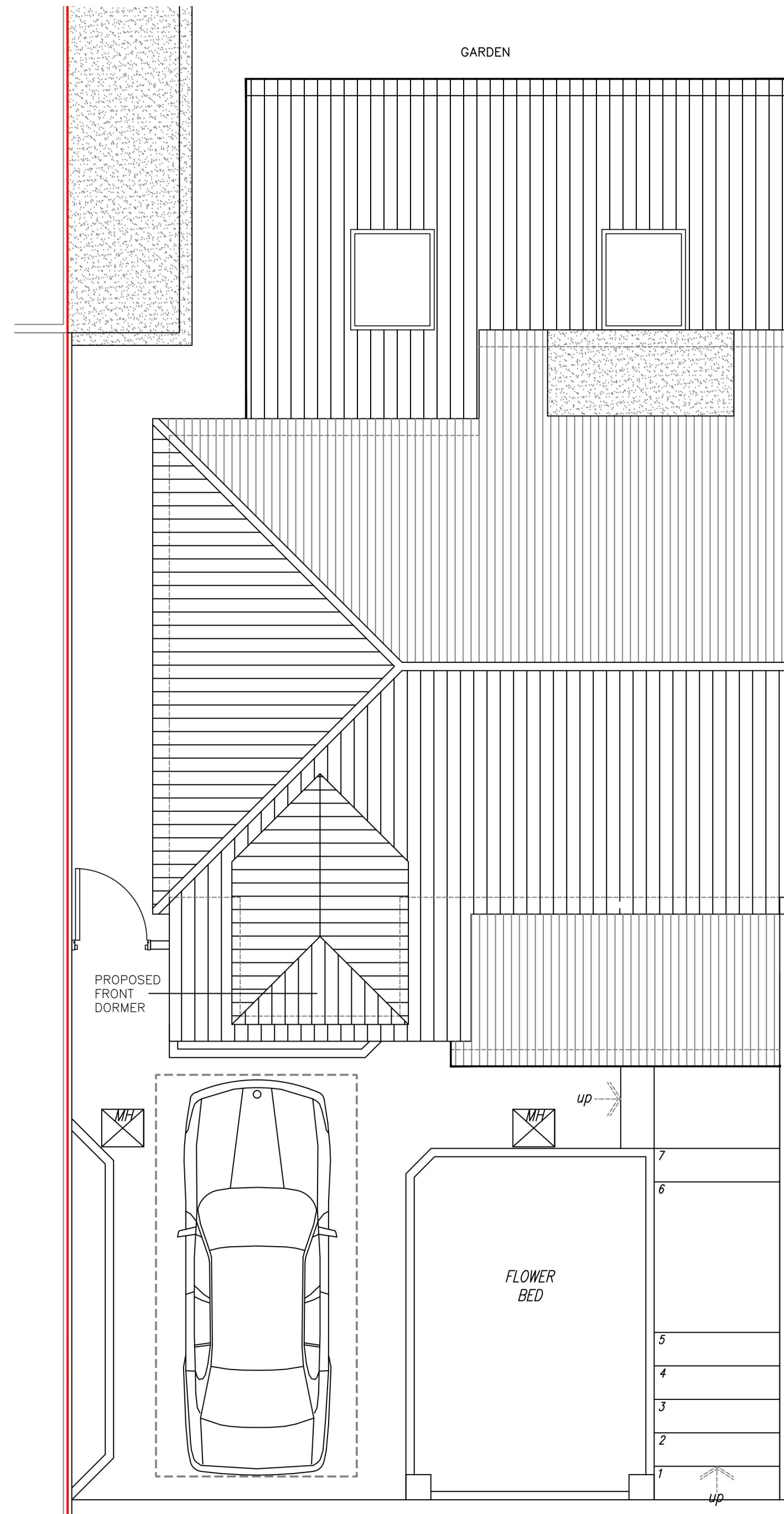
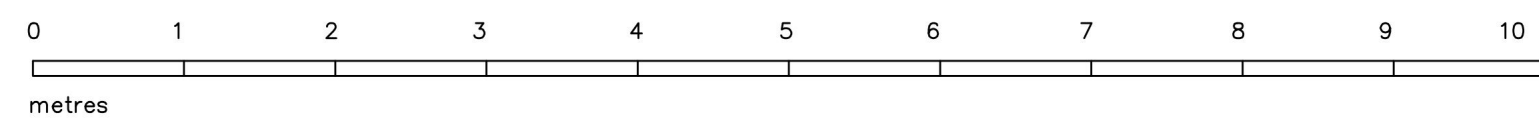
PROPOSED REAR ELEVATION

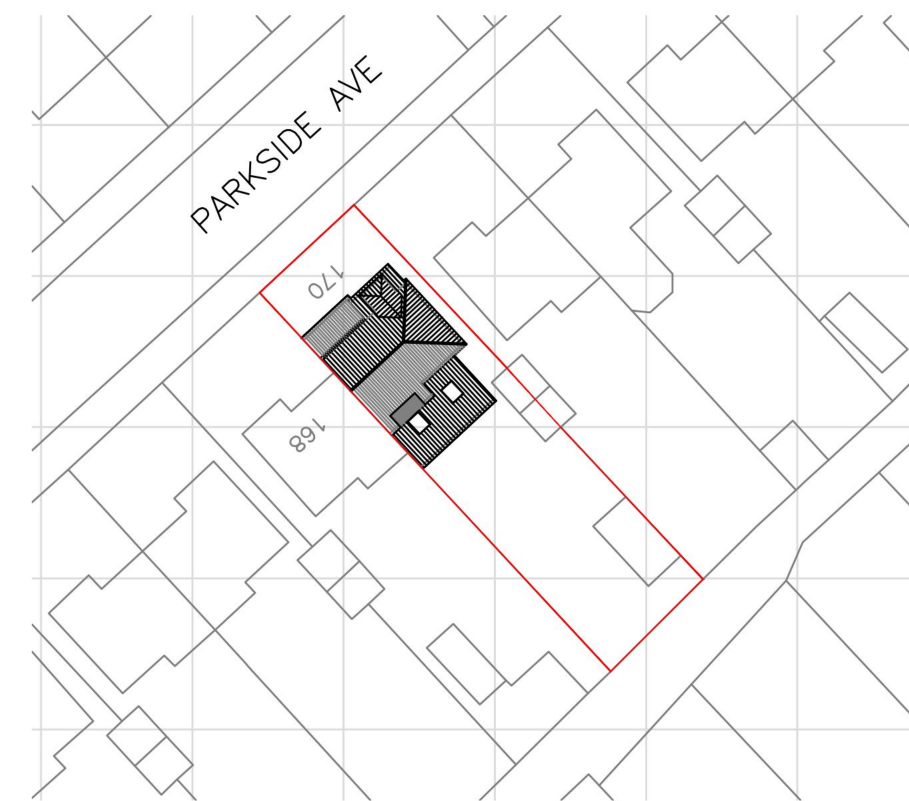

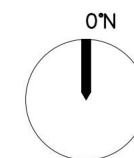
